All FCTC Industrial and Culinary students must take CASAS and Test of Adult Basic Education (TABE) Assessment unless the requirements for exemption are met*

The Florida Department of Education requires that all Career and Technical Education (CTE) students meet basic skills requirements for program exit. Below you will find the CASAS and TABE assessment requirements for our programs.

 - The waiting period to retaking the same assessment is based on individual student needs not the number of days

To Schedule Your Test

- Students not participating in Academic Coaching will visit Registration to pay the \$25 fee to retake
- There is a 90-day waiting period between retaking the same assessment
- Office hours are Monday – Friday 8:00 AM – 3:00 PM
- At least 24-hour notice is required for all appointments
- **SEATING AVAILABILITY IS LIMITED** to maintain social distancing
- Students who arrive more than 15 minutes past their start time will not be admitted to test until the next available start time
