First Coast Technical College (FCTC) signed and returned to the Department of Education the certification and agreement on April 21, 2020.

2. The total amount of funds that the institution will receive or has received from the Department pursuant to the institution's Certification and Agreement [for] Emergency Financial Aid Grants to Students under the CRRSAA and ARP (a)(1) and (a)(4) programs.

First Coast Technical College has received \$154,178 under the HEERF CARES Act to be awarded to students as emergency financial aid grants.

3. The total amount of Emergency Financial Aid Grants distributed to students under the CRRSAA and ARP (a)(1) and (a)(4) programs as of the date of submission (i.e., as of the initial report and every calendar quarter thereafter).

As of June 30, 2021, First Coast Technical College has distributed a total of \$155,100 to students. This amount constitutes \$154,178 of the student portion and \$922 of the institutional portion.

4. The estimated total number of students at the institution that are eligible to receive Emergency Financial Aid Grants to Students under the CRRSAA and ARP (a)(1) and (a)(4) programs.

As of June 30, 2021, First Coast Technical College deemed 200 students were eligible to receive Emergency Financial Aid Grants to students under CRRSAA and ARP (a)(1) and (a)(4) programs.

5. The total number of students who have received an Emergency Financial Aid Grant to students under the CRRSAA and ARP (a)(1) and (a)(4) programs.

A total of 200 students were disbursed CARES Act funds on June 30, 2021 using the following chart:

First Coast Technical reviewed students who met all of the qualifying criteria listed under "Who is Eligible for HEERF II Funds?" located on the CARES Act section of FCTC's website. It was determined that HEERF II funds would be disbursed in accordance with the chart noted above.
