Open Door Grant funds are applied after federal and state aid, or third-party payments, to cover a maximum award equal to the amount needed to cover 100% of tuition for the term. First Coast Technical College is required to reduce or cancel the grant award if the student later becomes eligible for other financial assistance during the 2024-2025 school year.
